### STORAGE RULES AND CONDITIONS

- Only Boats, Vehicles, or Trailers recorded on this agreement shall be parked in the assigned space.
- No Littering on premises
- Rent is paid in full in advance. There will be no prorated rates or refunds if you cancel contract before term is up.
- Storage of all boats and/or trailers is done solely at the risk of the owner.
- Full Performance Marine, Inc. is not responsible for items left on the premises, personal injury and/or any damages to boats, trailers or personal possession by any cause.
- The combination for the lock on the gates will be given to each person that has paid in full for a storage space.
- No outside contractors or individuals are permitted to work on boats at FPM Facility while in storage.
- I understand that if I cause any damage to any FPM storage building, (backing into the buildings, etc.), I am liable for the damages.
- I am fully responsible for blocking or chucking my trailer tires while my boat is in storage.
- I understand that I am not permitted to advertise my boat for sell on FPM property.
- I understand FPM retains the right, and option, to remove any boat from inside or under roof storage and be placed in outside storage for any bills overdue more than 30 days.
- I understand FPM may, at its option, institute such legal proceedings as may be necessary to collect any unpaid bills and that I will be responsible for reasonable attorney's fees and court costs in addition to unpaid charges. I give FPM my permission to sell my boat for payment of unpaid charges if the said charges remain unpaid for two years.
- Storage during winter months is not accessible. Boats are packed in enclosed buildings and some under roof buildings will have two boats per bay.
